# Your step by step guide to administering an estate

1. The Executor of the Will, or the family of the deceased if there is no Will, confirm they wish Rowlinsons to act in the administration of the estate.
2. We will write to all institutions where the deceased held assets, notifying them of the death and requesting valuations.
3. We will advise of the options in respect of any residential property.
4. When all the values are known we will prepare the Inheritance Tax forms and Oath and arrange a meeting with you to sign the documentation.
5. We will submit the application for the Grant to the Probate Registry and deal with the payment of any Inheritance Tax.
6. Once we receive the Grant from the Probate Registry we will forward this to all financial institutions asking them to close the various accounts and investments.
7. We will receive the monies in, pay any debts owing and deal with the sale or transfer of any residential property.
8. Estate Accounts will be prepared, showing monies received in the estate and monies paid out of the estate.
9. We will distribute the monies to the beneficiaries of the estate in accordance with the Will, or if there is no Will in accordance with the rules of intestacy.
